## Summary

Limited studies have been conducted on the private security industry in Niger despite prevalent security challenges in the country such as Boko Haram and other jihadists, ethnic rebellions, and military coups. One area in which private security companies (PSCs) play a role is the extractive sector. Following the kidnapping of seven employees of a French mining company by a jihadist group in 2010, mine security was strengthened with additional military, police, and PSC personnel. Some of the PSCs contracted to increase security around the mines are reported to belong to former leaders of the Touareg rebellion in the 1990's.<sup>ii</sup> Reports show that foreign PSCs are also operating in the country, such as the French PSC, Experts Partenaires pour l'Entreprise à l'Etranger (EPEE).<sup>iii</sup>

It has been reported that one of the largest PSCs in Niger is the Société nigérienne de sécurité (SNS), which employs 1,500 agents.<sup>iv</sup>
